Update for Ang Mo Kio Town Council and Jalan Kayu Town Council

As required by the Town Councils Act, the Ministry of National Development (MND) has issued the Town Councils (Declaration) Order 2025 to facilitate the establishment of Town Councils following General Election (GE) 2025.

A Town Council provides municipal services in the public housing estates in its area of responsibility.

The Town Councils Act limits a Town Council to cover a maximum of three constituencies. Therefore, the Ang Mo Kio Town Council (AMKTC) will be reconstituted to cover Ang Mo Kio GRC, Yio Chu Kang SMC and Kebun Baru SMC, while a new Jalan Kayu Town Council (JKTC) will be formed to serve residents in Jalan Kayu SMC.

Mr Henry Kwek will chair AMK TC. He will be assisted by Ms Jasmin Lau and Mr Darryl David as the Vice-Chairs. Mr Ng Chee Meng will chair JK TC.

Mr Ng said, "I assure Jalan Kayu residents that there will be no disruption to their municipal services nor any changes in Service and Conservancy Charges (S&CC) as a result of the town council changes in the transition. The current Managing Agent, CPG Facilities Management, will continue to serve Jalan Kayu for the time being. We are also reviewing the development plans of Jalan Kayu town, and look forward to sharing some exciting updates with residents in August."

Mr Kwek said, "Jalan Kayu will continue to be part of the extended Ang Mo Kio family. Ang Mo Kio Town Council will work closely together with Jalan Kayu Town Council, so that we can enjoy economies of scale and secure the best services and rates for our residents. In addition, we will continue to co-organise signature events so that our residents can come together and enjoy these festivities as one Ang Mo Kio family".

Jalan Kayu SMC residents who currently pay their S&CC in cash are advised to make arrangements to pay the Jalan Kayu Town Council starting from 1 August 2025. Those who currently make GIRO or recurring credit card payments need not take any action, as these payments will be seamlessly transferred to the Jalan Kayu Town Council.
